What we expect of visitors to our school

When you visit Thornton there are some guidelines we would like you to follow.

- Firstly please wear your badge at all times so that we know you are an authorised visitor to the school.
- If you are a regular visitor and have a DBS certificate then we will need sight of this for our Single Central Record.
- Please do not use your mobile phone whilst in school for any reason.
- If you see anything at all relating to the Safeguarding of children that concerns you do not leave the school until you have spoken to the DSL, Mrs Simmons, or one of the Assistants. You can find their information in this leaflet.

At Thornton we pride ourselves on our Safeguarding practices. You can help us to maintain this good practice and keep all our children safe.

What do we do to keep children safe?

DBS Checks

DBS stands for Disclosure and Barring Service. Anyone who works regularly with children in Thornton need to have a clean DBS certificate. All staff including supply staff, regular visitors and volunteers, as well as members of the Governing Body, are subject to Disclosure and Barring Screening (DBS) checks. This is to ensure that unsuitable people are prevented from working with our children.

If you have a DBS certificate and visit school regularly we will expect to see this certificate. If you want to work or volunteer at Thornton you must have a DBS before you start working with us.
